2024 OSHAWA PEONY FESTIVAL ART CONTEST PRESENTED BY PANERA BREAD

Terms and Conditions:

• The 2024 Oshawa Peony Festival Art Contest Presented by Panera Bread (the "Contest") voting will begin on June 8, 2024, at 11:00 a.m. and close on June 9, 2024, at 3:00 p.m. (Eastern Time).

How to Enter:

• To enter the Contest, complete the online entry form by Thursday, June 7, 2024 at 11:59 p.m. www.oshawa.ca/peony

Drop Off and Pick Up of Artwork:

- Bring your artistic interpretation of a Peony, in any medium (painting, drawing, sculpture, etc.) to the Children's Arena located at 155 Arena Street in Oshawa (the "Arena"), on Friday, June 7, 2024, between 10:00 a.m. and 4:00 p.m.
- Artwork entered in the Contest must be picked up from the Arena on June 9, 2024, between 3 p.m. and 5 p.m.
- After June 9, 2024, at 5:00 p.m., any remaining artwork entered in the Contest will be taken to the Civic Recreation Complex, located at 99 Thornton Road South in Oshawa (the "Complex"). Arrangements can be made for pick up at the Complex by emailing specialevents@oshawa.ca.
- Any artwork entered in the Contest and not picked up from the Complex by June 16, 2024, by 4:00 p.m. will be disposed of by The Corporation of the City of Oshawa (the "City") in the appropriate manner.

Criteria and Requirements:

- The Contest is open to all ages. All entries for youth under 18 years of age
 must include the name and contact information of the youth's legal guardian,
 and the legal guardian must agree to, and accept, the Terms and Conditions
 of the Contest.
- No purchase is required to enter the Contest.
- Only one (1) entry may be submitted per Contest entrant.
- The maximum size of an entry is 24" x 24" x 24".
- The City will provide tables to display the artwork during the 2024 Oshawa Peony Festival.
- Artists must supply an easel or display prop if required to display their artwork.
- All artwork submitted must be the sole creation of the Contest entrant. Accordingly, artworks shall not contain any content taken from the internet,

- copyrighted material and/or material which incorporates another person's work.
- By participating in the Contest, the entrant acknowledges and agrees that City staff may screen all entries and the City in its sole and absolute discretion reserves the right to reject any entry for any reason, including, but not limited to, vulgarity, obscenity or any form of criminal activity and/or violation of these Terms and Conditions. The City shall not be required to give the entrant any notification or reason if it rejects their artwork.
- The City reserves the right to select which artwork(s) will appear on the City's Peony Festival Contest Page and/or the City's social media accounts on Facebook, Instagram or Twitter #OurOshawa, #OshEvents or #OshPeony. Potential winners will be contacted by the City via email or phone. By submitting artwork for the Contest, the entrant consents to the City contacting the entrant by email or phone.

Prizes:

- The first place prize for the Contest includes the following and will be awarded to the artwork entry that receives the most number of eligible votes:
 - one (1) "You Pick Two for a Year" coupon from Panera Bread (approximate value of \$320) (the "First Prize Coupon"), along with Panera Bread swag, which will be awarded to the artwork entry that receives the most number of eligible votes. The First Prize Coupon allows the Contest winner to pick one (1) eligible Panera Bread You Pick Two Combination for free per month for twelve (12) months, subject to Panera Bread's terms and conditions; and
- The second place prize for the Contest includes the following and will be awarded to the artwork entry that receives the second most number of eligible votes:
 - one (1) "Salad for a Year" coupon from Panera Bread (approximate value of \$180) (the "Second Prize Coupon"), along with Panera Bread swag, which will be awarded to the artwork entry that receives the second most number of eligible votes. - vote for one (1) entry. The City reserves the right to reject any votes which they suspect to be multiple votes.
- Prior to claiming a prize, potential winners must show proper photo identification and provide any other information required by City staff to confirm the winner's identity and eligibility for the Contest.
- Employees of the City are not eligible to win a prize in the Contest.
- No person is eligible to receive more than one (1) prize in the Contest.
- The City reserves the right to cancel the Contest for any reason whatsoever without further notice or compensation.
- By participating in the Contest, entrants hereby provide the City with an unlimited, royalty-free licence to use photograph(s) of their artwork submitted for the Contest, including, but not limited to, use in all City communications, City advertising, and publicity purposes, without any compensation whatsoever to the entrant.
- By participating in the Contest, entrants hereby permit the City to use the entrant's name, city of residence, and photograph of their artwork for advertising or publicity purposes without any compensation whatsoever to the entrant.
- By participating in the Contest, entrants hereby release and hold harmless the City from any and all actions, charges, claims, costs, damages, demands, liabilities, losses, suits, proceedings, costs and expenses pertaining to the entrant's participation in the Contest and/or the potential Contest winners' redemption of the Coupons.
- By participating in the Contest, entrants agree that all decisions of the City and
 its employees in relation to the Contest are final and binding. Entrants also
 agree that the selection of the prize winners by the City in accordance with the
 public vote is final and not subject to any right of appeal or review.
