Special Consideration Regarding Garbage Bag Limits Information

About the Program:

- The program applies to:
 - o a resident with a medical condition that generates excessive waste;
 - o a resident with three (3) children under the age of 3; or
 - a resident with a disability who is unable to transport a full sized bag to the curb and needs to distribute their waste between smaller bags.
- The City will provide participants with an annual allotment of bag tags (50 tags).
- Participants can then go beyond the bag limit when placing waste at the curb by affixing a bag tag to each additional bag.
- Participants are responsible to comply with all other requirements in the City's Waste Collection By-law, No. 113-2008.

Criteria for Participation:

- Resident must live in a single-family dwelling.
- There must be no able-bodied person living at the residence.
- Proof of disability or medical condition is required.

Instructions to Resident:

- Submit a completed application to Service Oshawa, City of Oshawa, 50 Centre Street South, Oshawa, Ontario L1H 3Z7, Fax: 905-436-5642 or email: service@oshawa.ca. For more information call 905-436-3311.
- Residents applying due to a disability must provide proof of eligibility.
- Please let Service Oshawa know if any conditions of your application change.
- Place a bag tag around the neck of each bag in excess of the four-bag limit every two weeks.
- If you have provided your license plate number, you may also take extra bags to the Region's Waste Management Facility located at 1640 Ritson Road North, at no charge. Garbage must be placed in clear plastic bags with a bag tag on each bag. Contact the Region of Durham for more information at 905-579-5264.
