2018 Municipal Elections – Candidate Compliance with Filing Requirements

In accordance with Section 88.23(4) of the M.E.A., the Clerk shall make available to the public a report setting out all candidates in an election and indicating whether each candidate complied with section 88.25. Candidates who failed to file a financial statement and auditor's report by March 29, 2019 (or by 2 p.m. on April 29, 2019, the day that is 30 days after the applicable day for filing the documents) are deemed to be in default.

In accordance with Section 88.23(2) of the M.E.A., candidates forfeit any office to which they were elected and are ineligible to be elected or appointed to any office to which the M.E.A. applies until the next regular election has taken place subject to Section 88.23(7) upon application to court for extension.
