

Municipal Elections Act Section 88.23 (3) (4) (5)

In accordance with subsection 88.23 (4) of the Municipal Elections Act (the Act), the Clerk shall make available to the public a report setting out all candidates in an election and indicating whether each candidate complied with section 88.25 of the Act.

Pursuant to subsection 88.23 (5) of the Act, the report mentioned in subsection 88.23 (4) shall be made available on a website or in another electronic format as soon as possible after April 30, in the year following a regular election.

In addition, under subsection 88.23 (3) of the Act, in the case of a default the clerk shall make available to the public the name of the candidate and a description of the nature of the default.

Accordingly, the report as follows sets out the candidates for the 2022 Municipal and School Board Elections in the City of Oshawa and their compliance with section 88.25 of the Act.
