2. Approval of Agenda

4. Introductions

5. Orientation

- Julie delivered a presentation to the members of the CDEIC on the organizational structure of the City of Oshawa, the division of powers between orders of government and the responsibilities of the lower-tier municipalities.
- Kaitlin delivered a presentation on the CDEIC's Terms of Reference.

6. Discussion of Group Norms

- Donald suggested that the discussion on group norms and selection of a procedure for decision-making be moved to the next meeting.
- Committee members agreed that discussion of these items should be deferred until October.

7. City Updates

• Kaitlin shared an opportunity to participate in Anti-Islamophobia training with the CDEIC. The members expressed interest in attending training that could be

completed outside of regular CDEIC meetings. Kaitlin will investigate options for in-person and virtual training and share details with CDEIC members.

- Kaitlin provided an update on the Lakeridge Health Inclusion, Diversity, Equity and Accessibility (IDEA) focus group that was conducted with members of the CDEIC in 2021.
- The findings of the project's community consultation have be compiled and are ready for dissemination. Staff from Lakeridge Health would like to share the results to the CDEIC.
- Members agreed to add this presentation to October or November meeting agenda. Kaitlin will organize with Lakeridge Health and schedule the presentation.

8. Review of Upcoming Meeting Schedule

- The group discussed the meeting dates that were approved at the September 2021 meeting of the CDEIC (October 26 and November 30). Members agreed to keep the meeting dates as is and continue meeting from 7:00 PM 9:00 PM.
