## Fire Permit Conditions

Signature of Applicant:

- 1. The applicant acknowledges having read By-Law 73-2012 and fully understands its provisions.
- 2. An issued fire permit shall remain at all times in the possession of a supervising adult during the burning of an open air fire.
- 3. The applicant is responsible for notifying Oshawa Fire Services by telephone at 905-433-1234 prior to the commencement of any fire authorized by this permit, and again at the conclusion of the fire.
- 4. The burning of any fire authorized by this permit shall be confined to daylight hours only (dawn to dusk).
- 5. The supervisor of the fire must ensure that smoke and fire residue will not affect neighbouring properties due to wind velocity and direction.
- 6. Dry brush and/or vegetation materials from the farm where the farm is located only to be burned and must be capable of being controlled or extinguished with the use of a loader/back hoe or other equipment.
- 7. The applicant is fully liable for any and all costs that may arise as a result of this fire.
- 8. The applicant and the supervising adult acknowledge and understand that the City of Oshawa shall not be liable to them or other persons for any direct, incidental, special, exemplary or consequential damages arising from the starting of any fire authorized by this permit, including, but not limited to: lost profits, loss of business, personal injury, property damage, or accidental damages suffered or incurred by any person.
- 9. The applicant is responsible for ensuring that the supervising adult (if different from applicant) complies with the requirements set forth in By-Law 73-2012.
