

When do I need a building permit?

The following is a list of common projects that require a building permit. Please note that this list is comprehensive, but not exhaustive. If you have further questions on if a permit is required, please contact us at 905-436-5658:

- 1. Accessory structure (detached garage, workshop, shed, carport, pool house)
- 2. Addition to existing building
- 3. Alteration affecting any system or structure
- 4. Awning cantilevered or supported on columns (not a house)
- 5. Banner attached to a building
- 6. Balcony, new; including repair to structure and/or guard (not a house)
- 7. Brick Veneer (see Siding)
- 8. Bridge pedestrian bridge appurtenant to a building
- 9. Building new structure having a building area of more than 10m2 (107.6 sq. ft.); less than 10m2 and contains plumbing
- 10. Building (Factory-Built) site assembled and factory-built building
- 11. Ceiling new and replacement (not a house)
- 12. Change of Tenancy with material alteration
- 13. Change of Use
- 14. Chimney a chimney of any type, including repairs
- 15. Crane Runway
- 16. Communication Tower mounted on a building
- 17. <u>Deck</u> new or replacement, includes platform attached to a building or above-ground pool, or accessible from building or acting as second means of egress (see item 12 below for permit not required)
- 18. Demolition of entire building or structure
- 19. Dish antenna mounted on a building, with a face area equal to or greater than 5m² (53.8 sq. ft.)
- 20. Door New or replacement of different size
- 21. Factory-built Building (see Building (Factory-built))
- 22. Farm Building construction
- 23. Fire Escape new or replacement
- 24. Fire Code Retrofit
- 25. Fire-damaged Building damage to systems of building, including smoke damage
- 26. Fireplace new, solid fuel (coal or wood) appliance; fireplace insert
- 27. Foundation for relocated building; lowering cellar floor; raising of a house; structural repair
- 28. Garbage Enclosure for garbage storage facilities when covered and exceeding 10 m2
- 29. Grow-Op repair to components of building
- 30. Guard new or replacement
- 31. HVAC System new; change of furnace type; extension of existing (not a house)
- 32. Insulation thermal insulation, interior finish, air and vapour barriers
- 33. Interior Finishing partitions; new exterior wall finish
- 34. Mobile Home (see Building)
- 35. Outdoor Place of Assembly. Outdoor Restaurant Patio (see items 61, 62 for stage & equipment)
- 36. Partition full-height including non-load bearing

- 37. Piping medical gases
- 38. Plumbing new system, including repair or replacement
- 39. Pole attached to a building (e.g., flag pole)
- 40. Pool Public swimming pool
- 41. Porch with a roof
- 42. Ramp barrier free, including handrail or guard, ramps with a slope greater than 1:20
- 43. Retaining Wall over 1.0m (39 inches) in exposed height, adjacent to public property or access to a building, or on private property to which the public is admitted
- 44. Retrofit (see Fire Code Retrofit)
- 45. Roof Dormer new; or Skylight requiring structural alteration
- 46. Roof Sheathing new
- 47. Septic System new; extension to existing
- 48. Siding new exterior cladding; replacement of exterior cladding; new over existing
- 49. Sign attached to a building, free standing structure (pole sign, projecting sign, ground sign, construction sign, real estate sign, etc.)
- 50. Solar Collector equal to or greater than 5m2 mounted on a building; solar hot water heater of any area
- 51. Stairs design and construction of interior and exterior stairs, steps, ramps, railings and guards.
- 52. Tent or Seasonal Structure greater than 60 m2
- 53. Tenant Change (see Change of Tenancy)
- 54. Trailer appurtenant structure greater than 10m2 to e.g., entrance stair & deck for temporary sales trailer with undercarriage (on wheels)
- 55. Underpinning foundation (see Foundation)
- 56. Wall (see Partition)
- 57. Wheelchair Ramp (see Ramp)
- 58. Wind Turbine Generator building mounted, any size; free standing with capacity greater than 3kW
- 59. Window new or replacement (see item 38 below for permit not required)
- 60. X-ray Equipment shielding
- 61. Temporary outdoor stage more than 60 m2 & any part is 3 m high, or more than 225 m2, or has any part of platforms or roof, wall or structure attached to stage is over 5m high
- 62. Temporary outdoor Prop, Lighting and Sound Tower greater than 3m high, or supports load greater than 115kg, or create a hazard to the public

When is a building permit not required?

The following are examples of work which do not require a building permit. Please note that this list is comprehensive, but not exhaustive. Even if a building permit is not required, compliance with the City of Oshawa Zoning By-law is required.

- 1. Addition when the total building area of the addition plus the existing building does not exceed 10m2 (107.6 sq. ft.)
- 2. Adding or replacing insulation
- 3. Alteration not affecting any system or structure
- 4. Awning cantilevered from wall of a house; light-weight, including retractable fabric awning
- 5. Balcony repair to structure and/or guard of a house
- 6. Building free-standing, having a building area of less than 10m2 (107.6 sq. ft.) without plumbing
- 7. Building (Factory-Built) mobile home or trailer with undercarriage (wheels) except for the sewer and water services (see Plumbing)

- 8. Ceiling of a house (not a fire separation)
- 9. Change of Tenancy with no material alteration
- 10. Chimney tuck pointing of mortar joints, replacement of precast chimney caps
- 11. Communication Tower television antenna for any building, standalone communication tower and their accessory building regulated by the federal government.
- 12. Deck for houses only of any size, with no roof above and not exceeding 600mm (24 inches) above ground level, or repair of existing with same.
- 13. Demolition portion of building when part of a building permit for new construction
- 14. Farm Building demolition
- 15. Fire Escape minor repair
- 16. Fire Code Retrofit replacement of fire door; installation of exit sign; patching holes in drywall
- 17. Fireplace gas, electrical, oil heating, cooking and cooling appliance
- 18. Foundation non-structural repair; replacement, repair or installation of foundation drainage system for existing building (except for structural repairs)
- 19. Garbage Enclosure enclosure when uncovered (i.e., without a roof)
- 20. Grow-Op no damage
- 21. Guard repair of a house
- 22. HVAC System add-on cooling system, air cleaner, in-line humidifier and furnace replacement for a house
- 23. Interior Finishing replacement of floor finish, ceiling (not a fire separation), carpeting of a house
- 24. Partition part-height, temporary, movable & demountable partition not required to act as a fire separation; cubicle partition
- 25. Plumbing repair or replacement of fixture (valve, faucet, fixture, water heater, etc.)
- 26. Exterior Ramp with a slope of 1:20 or less; landscaping
- 27. Retaining wall located on private property to which the public is not admitted, permitted by the Site Alteration Bylaw; not within angle of repose of a building
- 28. Replacement of doors and windows of the same size and type as existing for houses only
- 29. Roof Skylight not requiring structural alteration for a house
- 30. Roof Sheathing minor repair; shingling of roof
- 31. Septic System abandoned or removed (decommissioned)
- 32. Siding new non-combustible siding over existing exterior cladding; exterior non-combustible stucco over existing masonry for houses only
- 33. Sign replacement of sign face (message) in existing sign box
- 34. Traffic sign, portable sign, sign in or on display window, sign painted on building; small directional, address and similar stand-alone incidental sign not greater than 0.40m2
- 35. Spiral stairs not required for means of egress (meet zoning setbacks)
- 36. Tent 60 m2 or less and 3.0 m clear of any structure (e.g., Car shelter for a house, farm building)
- 37. Temporary Performance/Event Stage & Equipment Temporary stage under 60 m2 & 3m high, less than 225m2, or has no wall or roof over 5m high. Temporary prop, lighting or sound tower less than 3m high or supports less than 115kg of equipment, and not create a hazard to the public (see items 61, 62 above)
- 38. Windows replacement of the same size and type as existing for houses only
