Where the Director, Municipal Law Enforcement and Licensing Services ("Director"), denies a person a Residential Rental Housing Licence and the person wishes to appeal the denial in whole or in part, the person may request a review by the Hearings Officer of the Director's denial or condition subject to each of the following;

- ☐ The person's right to request a review expires on the tenth (10<sup>th</sup>) day after notice of the Director's decision is given to the person.
- ☐ A Hearing will not be scheduled until the person has paid the fee prescribed by the General Fees and Charges By-law.
- ☐ The person shall be given seven (7) days notice of the date, time, and place of the Hearing.
- ☐ The Hearings Officer shall not make a determination with regard to the appeal request unless the Hearings Officer has given the person and the Director an opportunity to be heard.
- ☐ The Hearings Officer may affirm the Director's decision or may exempt the person from all or any part of the Licensing By-law where the Hearing Officer is satisfied that affirming the Director's decision or granting and appeal would maintain the general intent and purpose of the Licensing By-law.
- ☐ The Hearings Officer may impose any conditions that the Hearings Officer determines are appropriate and any condition imposed in relation to an appeal is final and not subject to review.
- ☐ Appeal Request fee is \$250.00 and the Fee for failure to attend a Hearing is \$100.00
